FIRE PERMIT APPLICATION REQUIREMENTS

*****SEE REQUIRED PERMITS ON WEBSITE*****

COMMERCIAL REQUIRED SUBMITTALS:

- 1) Digital submission bearing the approval stamp of the City of Creve Coeur, Maryland Heights, or St. Louis County.
- 2) All plans for construction shall bear an original seal, signature, and date of a Missouri-registered architect or engineer on each sheet of the plans.
- 3) All revisions must include a letter outlining locations of changes within plans.

SITE PLANS:

- 1) Digital plans, to scale, showing site development, landscaping, building (s) and Fire District apparatus movements on the plot.

SPRINKLER AND/OR FIRE ALARM SUBMITTALS:

- 1) ***Sprinklers/Fire Suppression (3 or more devices):***
 - A. Digital plans with complete hydraulic calculations along with cut sheets on all devices and all other required items for submittal for plan review per **the latest version of NFPA 13.**
 - B. Both St. Louis County and Creve Coeur Fire District issue sprinkler permits when the project is in St. Louis County (**separate plans submitted to County**).
 - C. Both Maryland Heights and Creve Coeur Fire District issue sprinkler permits when project is in Maryland Heights (**plans must be submitted to Maryland Heights first if there are 5 or more sprinkler heads, then to the Fire District**).
 - D. **City of Creve Coeur** does not issue sprinkler permits.
- 2) ***Fire Alarm (3 or more devices and all fire alarm control panels):***
 - A. Digital plans containing all required items submitted for plan review per **the latest version of NFPA 72.**
 - B. Maryland Heights and Creve Coeur Fire District issue fire alarm permits when project is located in Maryland Heights and Creve Coeur Fire District (**plans must be submitted to Maryland Heights first. Maryland Heights only if 5 or more devices**).
 - C. **City of Creve Coeur & St. Louis County** do not issue fire alarm permits.
All sprinkler and fire alarm plans shall bear the original seal, signature, and date of a Missouri-registered engineer on each sheet of the plans.

FEES:

The fire permit fee for plan review and inspections shall be based upon the following schedule:

COMMERCIAL BUILDINGS, SPRINKLER, FIRE ALARM, INDV. SITE PLANS, OR HOOD SUPPRESSION SYSTEMS AND ALL OTHER TYPES:

Based on estimated cost of construction - \$200.00 plus \$3.50 per \$1,000.00 of cost of construction.

MASTER SITE PLAN AND COMMERCIAL PERMIT EXTENSIONS:

Based on a flat fee of \$200.00 per event.

Starting construction without a permit: Any work started without permit shall result in the doubling of the permit fee up to \$500.00. No inspections will be made until the fee is paid by check or credit card. A 3% credit card transaction fee applies.

LOST PLANS/EXTRA INSPECTION FEE/FINE: \$200.00 (paid by check or credit card prior to reinspection) as stated in the Ordinance 24-2 amendments.
